

Kindly take note of the following Share Consolidation exercise by **PHARMANIAGA BERHAD ("PHARMA")** (stock code: 7081):-

CONSOLIDATION OF EVERY 5 EXISTING ORDINARY SHARES IN PHARMANIAGA BERHAD ("PHARMA") ("PHARMA SHARE(S)") INTO 1 PHARMA SHARE ("CONSOLIDATED SHARE(S)") ("SHARE CONSOLIDATION")

In relation to the Share Consolidation undertaken by PHARMA as a SPEEDS Corporate Exercise, Bursa Malaysia Securities Berhad would like to highlight that:

(a) on or after the Ex-date on 08 Jun 2026, trading of PHARMA shares will be based on the newly adjusted share after the Share Consolidation of PHARMA shares,

(b) on the basis of settlement taking place after 09 Jun 2026 with consolidated PHARMA shares, any entitled shareholder who owns PHARMA shares as at Ex-date may sell only up to the maximum PHARMA shares he expects to receive after the Share Consolidation, i.e. the reduced amount, on or after the Ex-date 08 Jun 2026

With the adjustments pursuant to the Share Consolidation effected on PHARMA shareholders' CDS account at the end of the Entitlement Date, an entitled PHARMA shareholder may use the following basis to estimate the maximum number of PHARMA shares that he may sell from the Ex-date until the Entitlement Date which is from 08 Jun 2026 until 09 Jun 2026.

Number of PHARMA shares that may be sold from 08 Jun 2026 until 09 Jun 2026	=	Number of shares held/5 <i>(All fractional shares computed should be disregarded)</i>

Illustration:

For example, if Mr X owns or purchases 500 PHARMA shares on cum basis on 05 Jun 2026, his CDS account would still show 500 PHARMA shares until 09 Jun 2026. However, as a result of the above Share Consolidation exercise, Mr X's 500 PHARMA shares in his CDS account will be adjusted to 100 PHARMA shares on the night of 09 Jun 2026 which is the Entitlement Date. Therefore, Mr X may, if he so wishes, sell only up to 100 PHARMA shares on or after the Ex-date i.e. from 08 Jun 2026 onwards.

The Consolidated Shares will be listed and quoted on the Main Market of Bursa Malaysia Securities Berhad on 10 June 2026, being the next market day after the Entitlement Date ("Listing Date").

Participating Organisation hereby caution all dealers and remisiers that, during the period from 08 Jun 2026 until 09 Jun 2026, they are only entitled to sell the maximum of 1/5 of the shares owned before the Ex-date.
